The successful candidate will contribute to the School's reputation as a recognised centre of international excellence. Applicants with research and teaching interests in behavioural/experimental economics or trade theory are particularly encouraged to apply. However, applications are welcomed from candidates with interests across all areas of the discipline, including development economics, international economics or microeconomics. They will be expected to deliver high quality teaching programmes at both undergraduate and postgraduate level, and assist with the administration of the School.

#### Main Duties and Responsibilities:

- To establish and develop a programme of research within the School, which complements and adds to the School's internationally recognised research activities.
- To support the School's research income generation plans by seeking external funding for the post holder's programme of research.
- To publish the results of the research programme in high quality international journals.
- To disseminate the results of the research programme through a variety of publication outlets and through national and international workshops, conferences and seminars.
- To develop teaching materials for lectures, tutorials and classes for the School's undergraduate and postgraduate programmes.
- To give lectures, tutorials and classes on the School's undergraduate and postgraduate programmes.
- To supervise Masters and PhD students preparing dissertations.
- To participate fully in the School's examination process through the preparation and marking of examinations and coursework and through participation in examination boards.
- To act as a personal tutor for undergraduate and postgraduate students and support their courses of study.
- To assist in the administration of the School through taking on specific administrative duties, membership of School Committees and participation in School meetings.
- To undertake other duties as required by the Head of School, appropriate to the post.
