University of Nottingham Alumni Scholarship

For University of Nottingham students continuing onto a second degree
– Alumni means that you are a graduate of The University of Nottingham

- A scholarship of 10% towards tuition fees is available to all overseas or EU (non UK) full time students – categorised as overseas or EU (non UK) for fee purposes – who complete a degree programme and graduate from:

The University of Nottingham UK
The University of Nottingham Ningbo, China
The University of Nottingham Malaysia

and register for another full time degree programme at The University of Nottingham UK.

This scholarship will be given on evidence of previous successfully completed study at The University of Nottingham and is for each year of study (up to 3 years).

Family Scholarship

*Family relates to brother, sister, children, husband or wife

- Where **brothers or sisters** register full time at The University of Nottingham UK for award bearing programmes, who are categorised as overseas or EU (non UK) for fee purposes, **each second and subsequent brother or sister is entitled to a scholarship of 10% of the first year's tuition fee.**

This scholarship will be given on evidence of the brother or sister relationship (i.e. copies of birth certificates) and of each brother or sister being registered on full time award bearing programmes (i.e. student ID number or copy of graduation certificate). The brothers or sisters need not be studying on programmes at the University together but may have registered some years apart.

- **Children of alumni** (i.e. children whose parents completed a degree programme at The University of Nottingham) who register full time at The University of Nottingham UK for an award bearing programme, and who are categorised as overseas or EU (non UK) for fee purposes, are entitled to a **scholarship of 10% of the first year's tuition fee.**

This scholarship will be given on evidence of the parent/child relationship (i.e. copy of birth certificate) and evidence of one of the parents being Nottingham alumni (i. e. student ID number or copy of graduation certificate).

- **Husbands or wives** who register full time at The University of Nottingham UK for award bearing programmes and who are categorised as overseas or EU (non UK) for fee purposes are entitled to a **scholarship of 10% of the first year's tuition fee for either the husband or the wife.**

This scholarship will be given on evidence of the spouse relationship (i.e. copy of the marriage certificate, the marriage must have taken place prior to registration) and evidence of both the husband and wife being registered on full time award bearing programmes (i.e. student ID number or copy of graduation certificate). It is not necessary for both spouses to be studying at the same time to gain this scholarship.



Alumni of Universitas 21 Institutions Scholarship

- The University of Nottingham is delighted to announce that any alumnus of a Universitas 21 institution registering at The University of Nottingham UK as a full time student, categorised as overseas or EU (non UK) for fee purposes, on an award bearing programme, is entitled to a scholarship of 10% of their first year's tuition fee. This scholarship will be given on evidence of previous successfully completed study at one of the U21 partner universities below (i.e. copy of graduation certificate).

Special News for Study Abroad and International Exchange Alumni

- The University of Nottingham is also delighted to announce that any former Study Abroad or Exchange student, categorised as overseas or EU (non UK) for fee purposes, who returns to The University of Nottingham UK to follow a full time full degree programme is entitled to a **scholarship of 10% of their first year's tuition fee.**

How to Apply

- Application forms for the above scholarships will be available at http://www.international/scholarships_and_finance/scholarships/_non-comp-schols-index.php after registration in September 2009. You must have registered on your programme in September 2009 to be eligible to apply.
- The scholarship is given once an application form has been completed and satisfactory evidence provided. **THE SCHOLARSHIP WILL BE REFUNDED TO THE FEE PAYER.**
- The scholarship **MUST BE CLAIMED WITHIN THREE MONTHS OF YOUR REGISTRATION** on your course.
- Candidates for all the above Scholarships must be registered for full time study and categorised as overseas or EU (non UK) for fee purposes.
- The non-competitive scholarships are processed during the first term. Due to the high volume of claims they will not be completed until the end of the term. If the whole of the tuition fee has been paid in order to gain the early payment discount a refund will be made by our Tuition Fees Office.
