




Successful Pro Bono Project Applications

Do you understand what the aims of the projects are?
Are you passionate about helping meet those aims?
Why do you have this passion (previous experience perhaps)?

Do's

- Discuss how you will benefit others
- Show some understanding of the aims and requirements of the particular project
- Show genuine passion, enthusiasm, commitment and interest
- Some experience to demonstrate certain skills (but not necessary as partaking in these projects will help you to gain experience)

Don'ts

- Mention the phrase 'this is for my CV'!
- Go over the word limit
- Have many spelling, punctuation and grammar mistakes
- Send a generic template you'd use for all projects (interest must be shown to that particular project)
- Submit past the deadline

Pro Bono Achievement Award

This Award recognises those who employ their time, skills and energies for the benefit of the local community.

1. To achieve the Pro Bono Award, you must complete either:
 - 3 events from 1 category (Penal, Education or Community)
 - 5 events across any of the categories (Penal, Education and Community)
 - 24 hours of A2J Innovations volunteering or 50 hours of PSU/ CCA volunteering
2. Upon completion, email: lawprobono@nottingham.ac.uk to evidence completed activities.
3. Wait for confirmation email and certificate!
