Operating Procedure:

- In the absence of a nominated First Aider leading the session, any accidents or injuries should be reported to Security for First Aid assistance, in line with UoN Policy (ext 18888 or 01159518888).
- Landscape Grounds Manager should be present for Student and Staff sessions and nominated event organiser for Friends Group events.
- Risk assessment should be shared with all present on the event day or prior to any activities/tasks undetaken.
- There should be a first aid kit available for all events and activities.
- PPE should be provided for all volunteers. Gloves, eye protection and Hi-vis vests should be provided.
- All equipment should be checked before and after works & stored away in a clean environment.
- Always seek advice and support from Team Leader/Management if unsure about any aspect of this RA.
