#### "Key concepts for informed choices"

Marnie Brennan attended a meeting called the 'Key concepts for informed choices across fields' in December at Kellogg College in Oxford – a coming together of a number of different evidence-based groups (e.g. policing, medicine, education, management, agriculture, veterinary, conservation, mental health, psychology, sociology etc.) to discuss whether there were common key messages across all disciplines that could be found and disseminated.
