

Prize Draw - Terms and Conditions

- 1. The prize draw is open to registered undergraduate and postgraduate students of the University of Nottingham ("University") aged 18 years or over ("students"). For the avoidance of doubt, the prize draw is not open to employees of the University, their families, agents or any third party directly associated with administration of the prize draw.
- 2. The prize draw is free to enter and no purchase is necessary.
- 3. From 8 March 2021 until 30 May 2021, the University will carry out Covid testing for students in three-week cycles ("Cycles"). Only those students who have taken a Covid test through the University's Asymptomatic Testing Service in each of the three weeks of a Cycle will be eligible to enter the prize draw. For the avoidance of doubt:
 - a. students who take three tests in one week or three tests over two weeks in a Cycle will not be eligible to enter the prize draw; and
 - b. students who complete one Cycle will be permitted one entry to the prize draw, students who complete two Cycles will be permitted two entries to the prize draw, students who complete three Cycles will be permitted three entries to the prize draw and students who complete four Cycles will be permitted four entries to the prize draw.
- 4. In order to enter the prize draw, students must scan the QR code available at the testing site and fill in the resulting form. Students only need to scan the QR code the first time they test.
- 5. A maximum of four entries per person is permitted for the prize draw.
- 6. The prize draw will take place on Monday 7 June 2021.
- 7. The University accepts no responsibility for entries not successfully completed due to a technical fault, technical malfunction, computer hardware or software failure, satellite, network or server failure of any kind.
- 8. Winners will be chosen by random draw performed by a computer on the date set out at paragraph 6 above.
- 9. For each prize draw:
 - a. the first 16 students whose names are drawn will receive £500;
 - the next 40 students whose names are drawn will receive an Apple 10.2"32GB iPad;
 - c. the next 40 students whose names are drawn will receive, at their discretion, either a 30 day gym pass for a University sports centre (to be redeemed by 31 July 2021) or a sports pack; and
 - d. the next 200 students whose names are drawn will receive a £5 voucher which can be redeemed (by 31 July 2021) at the following catering outlets: University Park (Cavendish Café, Coates Café, Food Court Portland Building, George Green Library, Hallward Library, Marmont Café, Starbucks), Jubilee Campus (including Starbucks), QMC (Greens, Hipps) and Sutton Bonington



(Mulberry Café and Costcutter). Please note that if, when you use the voucher, your bill is less than £5, you will not get any change and you will not be able to use the voucher again. If you use the voucher and your bill is more than £5, then you will have to pay the difference.

10. For the avoidance of doubt:

- a. a student can win a prize in each of the categories set out at paragraph 9 above, i.e., four prizes in total; but
- b. if a student's name is drawn for a prize they have already won, then their entry will be returned to the draw and the next student drawn will win that prize, provided that they have also not already won that prize, in which case their entry will also be returned to the draw and another student drawn until such time as the prize can be appropriately allocated.
- 11. The winners will be notified by e-mail, sent to their student e-mail address, by 8 June 2021 and must provide a postal address and/or bank account details as applicable to claim their prize.
- 12. If a winner does not respond to the University within 7 days of being notified by the University, then that winner's prize will be forfeited and the University will be entitled to select another winner in accordance with the process described above.
- 13. The prizes will be sent to the winners by post and/or bank transfer within 14 days of them providing a postal address and/or bank account details in accordance with 11 above.
- 14. The prizes are non-exchangeable, non-transferable and no cash alternative is offered for the non-cash prizes.
- 15. The University reserves the right to replace any prize with an alternative prize of equal or higher value if circumstances beyond the University's control make it necessary to do so.
- 16. The decision of the University regarding any aspect of the prize draw is final and binding and no correspondence will be entered into about it.
- 17. The University must either publish or make available information that indicates that a valid award took place. To comply with this obligation, the University will send the surname and county of major prize winners and, if applicable, copies of their winning entries, to anyone who e-mails sam.woolley@nottingham.ac.uk or writes to the Performance, Planning and Strategic Change Unit, Executive Office, Trent Building, University Park, Nottingham NG7 2RD (enclosing a self-addressed envelope) within one month after the closing date stated in paragraph 6 above. If you object to any or all of your surname, county and winning entry being published or made available, please send an e-mail to sam.woolley@nottingham.ac.uk or write to the address set out earlier in this paragraph 17. In such circumstances, the University must still provide the information and winning entry to the Advertising Standards Authority on request.
- 18. Participants are deemed to have accepted and agreed to be bound by these terms and conditions upon entry. The University reserves the right to refuse entry, or refuse to award prizes, to anyone in breach of these terms and conditions.



- 19. The University reserves the right to hold void, cancel, suspend, or amend the promotion where it becomes necessary to do so.
- 20. Insofar as is permitted by law, the University, its agents or distributors will not in any circumstances be responsible or liable to compensate any winner or accept any liability for any loss, damage, personal injury or death occurring as a result of the taking up of a prize, except where it is caused by the negligence of the University, its agents or distributors or that of their employees. Your statutory rights are not affected.
- 21. Personal data supplied during the course of this promotion will only be processed in accordance with the University's <u>Privacy Notice set out at the end of these terms and conditions</u>. Please also see paragraph 17 above with regard to the announcement of winners.
- 22. The prize draw will be governed by English law and entrants to the prize draw submit to the exclusive jurisdiction of the English courts.
- 23. The University running this prize draw is the University of Nottingham of University Park, Nottingham, NG7 2RD.
