NOTES ON COMPLETION OF CURRICULUM VITAE FOR PROMOTION

The purpose of the CV is to provide a detailed account of the individual's contribution and achievements.

General Notes:

- All pages must be consecutively numbered. Please give surname and initial as a 'header' on top of each page.
- Details in the CV should be kept as concise as possible and information provided on the CV should not be repeated on the relevant promotion Pro Forma.
- Candidates are encouraged throughout to evidence achievement/contribution within the current role (including new achievement/contribution since the previous promotion or since being recruited to the University).
- Reference may be made to reviews of an applicant's own publications if the review appeared in
 publications of acknowledged scholarly standing. Review by applicants of the work of others
 may be listed in the CV if these are judged to be of major significance. It will be for the
 Promotions Committees to decide on their relevance in consideration of a case for promotion.
- When describing teaching activity and successes please include details of both undergraduate and postgraduate teaching and supervision.

SECTION B - TEACHING AND CURRICULUM LEADERSHIP

- List the lectures, laboratory or exercise classes, CPD programmes, tutorials, field courses including the level of courses etc for which you are responsible to your unit during the **2020-2021 academic year**. Estimate the number of undergraduate and postgraduate students involved in each and the total number of contact hours on an annual basis, presenting the information in a table. Describe your contribution to undergraduate and postgraduate course preparation, teaching and assessment for University qualifications. Historic SET scores, from prior to March 2020, are still available and can be combined with more recent evidence for teaching excellence.
