Changes in the Editorial Team

Professor David Harris, Co-Director of the Human Rights Law Centre (HRLC), University of Nottingham, has stepped down from his position as a Chief Editor of the *Human Rights Law Review* (HRLR). The HRLR was launched in 2001. Under his leadership for the past 20 years, it has become one of the foremost specialist academic journals promoting awareness, knowledge and discussion on human rights law and policy. Associate Professor Sangeeta Shah is also stepping down from her role as a Co-editor of the Shorter Articles and Recent Developments Section of the *Review*. She has played a major role in the success of the *Review*. The expertise and advice of Professor Harris and an Associate Professor Sangeeta Shah will continue to support the work of the *Review* as they have both agreed to be members of the Editorial Board. Carla Buckley, HRLC Research Fellow, has supported the journal's growth and success in her role as an Associate Editor for most of its journey. The *HRLR* will remain a flagship publication of the HRLC, which continues to provide it with administrative support.

New Editorial Team

From Volume 21 (2021), the *Review* has a new editorial team. Three new editors have been appointed.

Dominic McGoldrick, Professor of International Human Rights Law, University of Nottingham, has been appointed as the new Editor in Chief of the *Review*. He is the Head of the Civil and Political Rights Unit at the HRLC and a former Co-Director of HRLC. He was previously the Co-editor of the Shorter Articles and Recent Developments Section of the *Review*.

Fiona de Londras is a Professor of Global Legal Studies, University of Birmingham, and an Honorary Professor at the Australian National University. Her research concerns constitutionalism, human rights and transnationalism.

Dr Shreya Atrey is an Associate Professor in International Human Rights Law at the Department of Continuing Education and the Faculty of Law, University of Oxford. She is based at the Bonavero Institute of Human Rights. Her research is on discrimination law, feminist theory, poverty and disability law. She is an associate member of the Oxford Human Rights Hub and an Official Fellow of Kellogg College.

Dr Hemi Mistry, University of Nottingham, will continue as a Book Review Editor.

Claire Hardwidge, University of Nottingham, has been appointed as an Assistant Editor. For a number of years, she has worked as the virtual editorial assistant for the *Review*.
