Found by inq that John broke the covenant [made with] Robert. Damages: 40d. Adjudged that Robert should recover 40d. v John. John in mercy for breach of covenant.

Since Henry is commissioned to carry water by bushels (*buseis*) to sell to all the people of Nottingham wishing to have the water, and Robert on Mon before Michaelmas last (24 Sept 1330) sent Alice, his servant, and his other servants to Henry and beseeched (*supplicavit*) him that [Robert] wished four horseloads (*summag*) of water to be carried to his house and she gave him 1d. in accordance with what it was accustomed to be sold [for]; Henry was unwilling to carry water to Robert but entirely refused and he called Robert a false [man] and an infidel and accused (*inposuit*) him that he pierced with a knife his bushel and all the bushels of Nottingham. Furthermore, he procured the sanction of the same [by] all his associates [and] that they should not carry water to Robert because Robert was unwilling to pay his stipend (*stipendium suum*). By that Robert was unable to have water for five weeks following neither from Henry nor from any of his associates by that he lost the flour (*farinam*) of two quarters of malt worth 10s. Damages: 40s. He produces suit. Henry comes and defends the force and says he is not guilty. [Inq.]
