On Thurs after the feast of St Martin 32 Edward III (15 Nov 1358) John sold William half an ox (*unum dimidium bovum*) and 4 sheep (*oves*) for 10s. which he ought to have paid at Christmas following (25 Dec 1358); he paid nothing but detained and still detains the money. Damages: 40d. He produces suit. William comes and defends the force and says he owes him nothing. Inq.

Damages: 13s.4d. He produces suit. Thomas comes and defends the force and says it was by William's default that he did not minister to the horse as he ought and so he did not break the covenant. Inq.
