16 ESSOIN PL Roger de Herpeswell complains of Henry of Warwick <essoin>. Plea: debt. He owes 33½d. ... for a man (*pro viro*) of the name of John of Chilwell; he did not pay ... [Damages]: 12d. Henry comes and defends and says he owes nothing. Inq.

17 ESSOIN PL Elkyn Fyscher complains of Ralph Waterleder <essoin>. Plea: debt. He owes 3s. for fish (*pro pisco*): kippers (*kyper*) bought from him; he did not pay but still unjustly detains. Damages: 12d. He produces suit. Ralph comes and defends and says he owes nothing. Inq.

18 ... BOTH ... Hamon of Ireton <put, 3d.> complains of William Cotyler <put, 3d.>. Plea: debt. He owes 28d. which he ought to have paid; he did not pay but detained. Damages: 12d. William comes and defends the force and says he owes nothing. Found that he owes

[nothing] except 20d. Damages: 3d. As to the rest, in mercy for an unjust [suit]. William in mercy for an unjust detinue of the debt.

19 CHARTER To this court come Hugh of Shelford, carpenter, and Denise his wife and seek a charter made to them to be enrolled. Grant by Hugh le Spicer of Nottingham and William, his son, to Hugh of Shelford of Nottingham, carpenter, and Denise, his wife, their heirs and assigns, of a plot of land (*placeam terr*) with appurtenances in the Saturday Market on Timber Row (*le Tymberrowe*) between the tenement of the said Hugh [of] Shelford on the western part and the lane which leads from the market to St Peter's church, Nottingham, on the [eastern] part; it abutts towards the south on the curtilage sometime of John of Bridgford of Nottingham. Warranty clause. Sealing clause. Witnesses: John Samon, mayor, Henry of Bradmore, Thomas of Bothal, bailiffs, William Colyer of the same, William Cupper of the same, and others. Nottingham, Tues the feast of Annunciation BVM in the above regnal year (25 Mar 1371).

40 ... Inq between Elkyn Fyscher and Ralph Waterleder <+, put> [in respite] ... Essoined. Inq. Found that he owes 3s. Damages: 3d.

41 ... Emma servant of John Trumpour complains of John Spark. Plea: trespass. On the first Sun in Lent (23 Feb 1371) he drew his knife, violently beat and bloodied her against the peace. Damages: 20s. She produces suit. John defends the words of the court and says he made no damage on her nor is he guilty. Inq. Found that he is not guilty.

42 ... Martin Tankardmaker <put> complains of Walter servant of Richard Colleson <offered by attorney>. Plea: trespass and bloodshed. On Sat the eve of Palm Sunday last (29 Mar 1371) Walter drew his knife and violently wounded and bloodied him against the peace. Damages: 40s. He produces suit. Walter defends the force [and says] he is not guilty. Inq.

43 ... Robert de Howdeyn complains of Hugh Pynner <put>. Plea: trespass. He stole and carried off his goods and chattels to the value of 40d. ... against Robert's wish and licence. Damages: 10s. Hugh defends and says he is not guilty. Inq.

44 ...2d. Robert de Howdeyn complains of Hugh Pynner <put>. Plea: covenant. On Whitsun⁵ last (25 May 1371), to have all chattels with his bows which he made for the following year as in a sample shown and warranted to him; he did not hold the covenant and the chattels were not well made (*habendi totum catallum arcis suis que fecerat per proximum annum futur' prout in quodam exemplo ei demonstraverat et warant' contra propter cov' non est tent' et catallum non bene fac*). Damages: 40s. Hugh [comes and] defends [the force] and says he is not guilty. [Inq.]

45 3d. ... Hugh Pynner <put> complains of Robert Howdeyn <offered>. Plea: trespass. He made an assault on him at his window and drew his knife against the peace and violently hit him and bloodied him. Damages: 10s. Robert defends and says he is not guilty. [Inq.]

46 6d. ... M William de England <offered, put> complains of Henry Durmeys <offered>. Plea: trespass. He stole (*solidavit*) his servant against his wish and the peace and unjustly

bound himself in his service without reason (*sine ratione*). Damages: 20s. Henry [comes and] defends [the force] and says he is not guilty. Inq. Found that he is not guilty.

47 ... 6d. John Alcok <offered> complains of Adam of Wollaton <essoin, put>. Plea: trespass. He complains as above in another suit. Adam defends and says he is not guilty. Inq.

48 3d. M John Turnour <offered by Clerk> complains of Geoffrey Smyth <+, put>. Plea: detinue. He detains a saw worth 18d. which he delivered to him to make (*ad fabricand*) and he still has not returned it. Damages: 12[d.] Geoffrey [comes] defends [the force] and says he delivered the saw; he does not detain it. Inq. Found that he should give (*dabit*) him 5d. for the saw. Damages: 1d.

49 ...3d. John de Normanton <offered> complains of Roger de Waltham <put>. Plea: debt. He owes him 5s. for his costs (*costag*) towards London. Damages: 40d. Roger defends and says he owes nothing. Inq.

50 3d. BOTH M Agnes Betdoghter <put> complains of Robert of Stanton <+, put, 3d.>. Plea: detinue. He detains 27s.1d. for 13 bushels of barley (*bussi ordii*) and he still has not paid her for the barley. Damages: ½m. Robert defends and says he owes nothing. Found that he owes in total 6s.8d. Damages: 6d.

51 6d. FOR AN UNJUST SUIT Richard de Norton, lister (*lyster*) <offered by clerk>, complains of Alice de Bulford. Plea: trespass. [She took] his goods to the value of 40d.: wool and yarn (*filo*) against the peace and his wish. Damages: 12d. Alice defends and says she is not guilty.

52 3d. ... William of Basford <offered> complains of Walter Larance <put>. Plea: debt. He owes 4d. for 2 pairs of hose (*calig*). Acknowledged 1d. As to the rest, he defends and says he owes nothing. Inq.
