Richard borrowed from him a *gadde* of iron for divers business to be made with the iron, to be restored in an uninjured state when Richard's work was done; he did not render the whole *gadde* but broken detaining a moiety of the iron; he still detains. Damages: 10s. He produces suit. Richard comes and defends the damage. He says that he [ought] not to reply to the plea because he says that at the time of the borrowing of the *gadde* of iron the lord King Henry was present in Nottingham and caused to be repaired a battle plot for his champions to battle in (*quadam placeam bell' pro campionibus suis in ea debelland'*); for the reparation of the plot the king's knight marshall, Oliver Mawlyvere, on the king's part sent and compelled William de Derley and Robert de Okley then bailiffs of Nottingham and all their servants, sub bailiffs to provide, dispose and ordain sufficient instruments to dig holes for the timbers and barriers around the plot until it should be finished; by which once by the bailiffs and sub bailiffs, [and] by the said Oliver, knight marshall, Richard was sent under pain of loss and life and limb to arrange for the making of the holes, by virtue of which order Richard took the iron for the king's use and handed it over to the said knight marshall. Richard says that he fulfilled the king's mandate, does not think he should reply to Henry in this plea but should be fully excused (*intendit non se responsere predicto Henrico ad hec placitum sed penitus excusori*). He puts in judgement (*et hoc ponit in judic'*). Henry comes and says that in borrowing the iron Richard did not certify him it was for the king's use or any mandate of the king but carried off that iron from him to be returned. He says that Richard should be held to reply to him concerning a moiety of the said iron. He puts in judgement. Day given to the parties to the next court to hear their judgement as the court shall adjudge.
