**1** INQ M ... John Shevyn of Colston Bassett <np, by [John] Moreton>, by John Moreton his attorney, complains of William Crophill of the same. Plea: debt of 5s. He says that he owes and unjustly detains 5s. for the wage of William his son retained with John from Michaelmas 18 Henry VI [29 Sept 1439] for a year in husbandry (*husbandr*), which William should have paid at the feast of All Saints following [1 Nov 1439]; he paid nothing but refused to pay and still refuses. Damages: 2s. He produces suit. William Crophill in his own person comes and says he owes him nothing. Inq. Plg: John Lovot snr for the def. Np. In mercy.

**2** M Henry Grene of Nottingham complains of John Rowe of the same <licence>. Plea: debt. John for a licence to agree in mercy.

**3** M John Balthwayt of Nottingham complains of Richard Strelley <licence>. Plea: debt. Richard for a licence to agree in mercy.

**Forinsec pleas held on Fri before the feast of St Denis in the said year [7 Oct 1440].**

**4** M John Castell snr of Nottingham <np. Plg: Robert Castell> np v John Sele. Plea: trespass against the king's peace. In mercy.

**5** DAY LAW William Parker, by Thomas Hurst his attorney, comes and John Freman, parson, by John Fossebrook, *bochr'*, def. Day given to the next court at the wish of the parties: Wed after the feast of St Luke [19 Oct 1440]. Law.

**Further forinsec pleas held on Thur before the feast of St Denis in the above year [6 Oct 1440].**

**6** INQ PLG PROS JOHN COST, ADAM REST Thomas Slurre of Colwick, by John Moreton his attorney, complains of William Fysshre of Nottingham, butcher <essoin>. Plea: debt of 3m 3s.4d. He says that William on Fri before the feast of the nativity of the BVM 19 Henry VI [2 Sept 1440] bought divers oxen from Thomas for 3m 3s.4d., to be paid at Michaelmas following [29 Sept 1440]; he paid nothing but refused to pay and still refuses. Damages: 6s.8d. He produces suit. William in his own person comes and says he owes him nothing. Inq. Plg: as above.

**7** INQ PLG PROS AS ABOVE The same Thomas complains of William Ingelbright of Nottingham, *bochr' <essoin>*. Plea: debt of 3m 3s.4d. He says that William Ingelbright on Fri before the feast of the nativity of the BVM 19 Henry VI [2 Sept 1440] bought divers oxen (*boves*) from Thomas, to be paid at Michaelmas following [29 Sept 1440]; he paid nothing but refused to pay and still refuses. Damages: 6s.[8d.] He produces suit. William in his own person comes and says he owes him nothing. Inq. Plgs: John Cattesworth, Thomas Pepur of Nottingham, *bochr'*, for the def.

**8** INQ PLG PROS JOHN EST, ADAM REST Henry Saxilby complains of John Hoght lately servant of the prior of Lenton. Plea: breach of covenant. He says that Henry on Mon before the feast of the invention of the HC 18 Henry VI [2 May 1440] agreed with John to make a road by giving John ... working from the spring of the soil to the access of the soil (*ad faciend' unam viam dando eidem in operand' ab ortu sol' usque ad occasim sol'*). John came to work at the first hour and left his work at the ... hour continuing of the hour of the day wholly between them agreed. [Damages]: 3s.4d. He produces suit. John comes in his own person and defends the force and says [he broke] no such covenant. Inq.

**9** LEVY M Edmund Wheteley in his own person complains of John Parsonez of Nottingham <essoin>, Richard Wodhall of the same, John Broude of the same and William Alen of [the same]. Plea: debt of 6s.8d. as part of a bond. Essoin on the first day. On the second day comes William Alen and acknowledges 6s.[8d.] ... Let him recover. Damages: 2d. William [and the others] in mercy. Precept to levy. Delivered by the pl at the instance of the mayor.

**14** INQ PLG PROS AS ABOVE William Wolaton in his own person complains of William Tailliour of Nottingham. Plea: detinue. He says that [William] Wolaton on Tues before the feast of nativity of St John the Baptist 17 Henry VI [23 June 1439] delivered in safe custody to William Tailliour a *barkstok'* with a ... of iron fixed thereon, and to restore it at the feast of St Peter advincula following [1 Aug 1439]; he restored nothing but unjustly detains the *barkstok'*. Damages: 6d. He produces suit. William Tailliour in his own person comes and says he owes him [nothing]. Inq.

**15** PAID M William Halyfax complains of John Tomson of Brinsley <licence>. Plea: detinue. John for a licence in mercy.

**16** M William Nosterfeld, chaplain, complains of William Webster of Bonnington <licence. Plg: Henry Smyth>. Plea: breach of covenant. William Webster for a licence in mercy.

**17** M John Shevyn and Robert his son, by John Moreton [their attorney], complain of William Crophill of Colston Basset <licence. Plg: William Flesshewer>. Plea: debt. William for a licence in mercy.

**18** M Henry Fermer complains of Richard Redeswell of Nottingham <+, licence>. Plea: debt. Defaulted. Richard for a licence in mercy.

**19** M John Robertson of Lenton <np> complains of Thomas Rand. Plea: trespass against the king's peace. Robert np. In mercy.

He says that William on Fri before the feast of the nativity of the BVM 19 Henry VI [2 Sept 1440] with force and arms (staff) took and led away 2 oxen worth 40s. Damages: 50s. He produces suit. William in his own person comes and says he is not guilty. Inq. Plg: John Cattesworth for the def. Thomas np. In mercy.

**25** INQ M [PLG] PROS AS ABOVE The same Thomas <np> complains of William Fysshre of Nottingham, *bochr'* <+>. Plea: trespass against the king's peace. He says that William on Fri before the feast of the nativity of the BVM 19 Henry VI [2

Sept 1440] with force and arms (staff) took and led away 2 oxen worth 40s. Damages: 50s. He produces suit. William in his own person comes and says he is not guilty. Inq. Plg: Richard Dalbury for the def. Np.

**26** INQ PLG PROS ... John Horspole jnr complains of William Dawe of Beeston. Plea: debt of 12s. He says that William owes and unjustly detains 12s. for cloth bought from him, which he should have paid at Michaelmas last [29 Sept 1440]; he paid nothing but refused to pay and still refuses. Damages: 2s. He produces suit. William comes, by John Alestre his attorney, and says he owes him nothing. Inq. Plg: John Alestre.

**27** [INQ] ... Geoffrey Forster, by Richard Dalbury his attorney, complains of Robert Parker, dyer (*dyestre*). Plea: trespass against the king's peace. He says that Robert on Tues before the feast of St Peter advincula 18 Henry VI [26 July 1440] with force and arms (staff) took and carried off 2½ yards of green cloth of the cloth of Agnes Wrigley of Chester worth 5s., 2 yards of blue (*blod*) cloth of the cloth of William Sherman worth 4s., leased to himself (*sibi dimisset*). Damages: 13s.4d. He produces suit. Robert in his own person comes and says he is not guilty. Inq. Plg: William Torlaton for the def.

**28** [INQ] ... The same Robert in his own person complains of the same Geoffrey. Plea: detinue. He says that Robert was retained with Geoffrey from the feast of St Peter advincula 17 Henry VI [1 Aug 1439] for a year as a dyer (*dyestre*) for a reasonable wage and a robe worth 6s.8d., of which salary the robe is in arrears as of today; Geoffrey refused to render the robe and unjustly detains it. Damages: 6s.8d. He produces suit. Geoffrey comes, by John Moreton his attorney, and says he detains no robe. Inq.

**29** [INQ] ... John Squier and Margaret his wife, by John Moreton their attorney, complain of Henry Bonyngton <essoin> and Alice his wife. Plea: debt of 5s. They say that Alice on Sat before the feast of St Thomas the Apostle ...<sup>1</sup> [c 21 Dec] bought from Simon Ilkeston of Nottingham ½ *playt* of lawn with 4 yards of linen cloth (*panni linii*?) to make chemises worth 5s., to be paid to Simon at the feast of the purification of the BVM following [2 Feb]; on the said day Margaret became Alice's pledger and fidejussor to Simon and agreed to pay Simon if Alice should not pay 5s. She did not pay by which the action accrued to John and Margaret to seek 5s. from Henry and Alice; they paid nothing but refused to pay and still

refuse. Damages: 20d. They produce suit. Henry and Alice come in their own persons and say they owe them nothing. Inq.

**30** [INQ] ... John Paunton of Clapton, by John Moreton his attorney, complains of William Webster of Ruddington <+, reattach, licence>. Plea: trespass against the king's peace. He says that William on Sun before the feast of the nativity of the BVM 19 Henry VI [4 Sept 1440] with force and arms (staff) made an assault on John, beat, affrayed and maltreated him. Damages: 20s. He produces suit. Defaulted. Afterwards he comes in his own person and says [he is] not guilty. Inq. Plg: John Bullur for the def.

**31** [INQ] ... Robert Rasyn and Alice his wife, by John Moreton their attorney, complain of Agnes Dyghton of Nottingham <licence. Plg: John Horspole jnr>. Plea: [trespass and contempt against the ordinance and statute of labourers. They say that Agnes] ... Michaelmas 19 Henry VI [29 Sept 1440] was retained with Robert and Alice to serve [from Michaelmas] for a year in housewifery (*huswyfre*); on Sun ... without reasonable cause Agnes withdrew from the service of Robert and Alice.<sup>2</sup> Damages: 6s.8d. They produce suit. Agnes in her own person comes [and says she is not guilty. Inq.] Agnes for a licence [in mercy].

Damages: 12d. She produces suit. [William in his own person comes] and says he owes her nothing. Inq.<sup>3</sup>

**42** M Richard Madershay <np> complains of Thomas Derby. Plea: trespass against the [king's] peace. Richard np. In mercy.

**43** M William Mee of Chilwell in his own person complains of William Reve of Clifton <caption>. Plea: debt of 11s.6d.: 7s.6d. for a bullock (*boviculo*), 2s. for a scythe, and 2s. for a calf bought from him, to be paid at the feast of St Martin 17 Henry VI [11 Nov 1439]. William Reve summoned. Has day on Mon after the feast of St Luke [24 Oct 1440]. The bailiffs return that he has nothing within their bailliwick by which he can be summoned. Precept to take William Reve's body.

**44** M William Nosterfeld, chaplain <np>, complains of William Webster of Ruddington. Plea: trespass against the [king's] peace. William Nosterfeld np.

**Forinsec pleas held on Wed after the feast of All Saints in the within year [2 Nov 1440].**

**45** ESSOIN William Fysshre def v John Howett pl. Plea: debt. Essonr: Richard Dalbury. Inq.

**46** M William Fysshre for a licence with Thomas Slurre in mercy. Plea: debt.

**47** M William Ingelbryght for a licence to agree with the same Thomas in mercy. Plea: debt.

**48** LEVY M Found by inq that William Dawe of Beeston owes John Horspole jnr 12s. Adjudged that John should recover v William 12s. and 4d. damages. William in mercy. Precept to levy.

**49** M Found by inq that Robert Parker is not guilty v Geoffrey Forster. Plea: trespass against the [king's] peace. Adjudged that Geoffrey should recover nothing v Robert but for his unjust suit in mercy. Geoffrey does not detain to Robert a robe. He says that William on Mon after the feast of nativity of St John the Baptist 18 Henry VI [27 June 1440] bought malt (*bras' ord*) for 19s.4d. from him, to be paid at Michaelmas following [29 Sept 1440]; he paid nothing but refused to pay and still refuses. Damages: 6s.8d. He produces suit. William in his own person comes and says he owes him nothing. Inq. Plg: William Odham.

**51** INQ M PLG PROS ADAM FOX, WILLIAM BOX William Angle <np> in his own person complains of Roger Wever servant of Thomas Trewe. Plea: trespass against the king's peace. He says that Roger on Fri before the [feast] of All Saints 19 Henry VI [29 Oct 1440] with force and arms (dagger) made an assault on William, affrayed and maltreated him. Damages: 13s.4d. He produces suit. Roger in his own person comes and says he is not guilty. Inq. William np. In mercy.

**52** INQ PLG PROS AS ABOVE Nicholas Bromfeld of Sneinton, by John Moreton his attorney, complains of William Bere, *glover*, of Nottingham <licence>. Plea: trespass against the king's peace. He says that William on Thur after the feast of the assump BVM 19 Henry VI [? 18 Aug 1440] with force and arms (staff) entered Nicholas' house against his wish, cut down (*seravit*) the gate, and took and carried off a nail worth 4d. Damages: 6s.8d. He produces suit. William in his own person comes and says he is not guilty. Inq. William for a licence in mercy.

**53** INQ PLG PROS AS ABOVE <rests, default of jurors> Thomas Marton, by John Moreton his attorney, complains of William Mason of Nottingham. Plea: trespass against the king's peace. He says that Thomas on Mon after the feast of nativity of St John the Baptist 18 Henry VI [27 June 1440] arrested flax (*linum*) and divers herbs growing in Thomas' garden worth 20d., 15d. for the rent of the garden; William on the same day with force and arms (staff) broke the arrest and took and carried off the flax and herbs. Damages: 2s. He produces suit. William in his own person comes and says he is not guilty. Inq.

**54** INQ PLG PROS JOHN REST, ADAM WEST Robert Hand[our] of Harby, by John Moreton his attorney, complains of William Swyper of Clifton. Plea: trespass against the king's peace. He says that William on Thur after the feast of St Laurence 18 Henry VI [11 Aug 1440] with force and arms (staff) lay in ambush, and, with so many foul words, such mutilating injuries put on his limbs (*tales inju[r]ias predicto Robert inponitur de mutulacione suorum membrorum*) he was not able to go (*non ausus fuit ire*) to any market on account of the fear of death. Damages: 100s. He produces suit. William in his own person comes and says he is not guilty. Inq. Plg: William Odham for the def.

**55** INQ PLG PROS RICHARD REST, ADAM FOX William Swypur, by Richard Dalbury his attorney, complains of Robert Hand[our]. Plea: trespass against the king's peace. He says that Robert on Tues Trinity Sun 17 Henry VI [2 June 1439] with force and arms (staff) took and led away a bullock (*boviculum*) worth 20s.

Damages: 20s. He produces suit. Robert in his own person comes and says he is not guilty. Inq. Plg: Ralph Stoyle for the def.

**56** INQ M PLG PROS ... Robert Strelley, by Richard Dalbury his attorney, complains of John Lele <licence. Plg: Richard Dalbury>. Plea: trespass and contempt against the ordinance and statute of labourers.<sup>4</sup> He says that John on the feast of St Martin 18 Henry VI [11 Nov 1439] was retained with Robert to serve him from the said feast for a year in husbandry (*husbandr*); on Sat after the feast of All Saints following [7 Nov 1440] without reasonable cause John withdrew from his service. Damages: 13s.4d. He produces suit. John in his own person comes and says he was [retained] to the feast of All Saints [1 Nov] and so is not guilty. Inq.

**57** INQ [PLG] PROS [AS] ABOVE William Fysshre, *bochr'*, complains of William Burton, *irenmonger* <+, inq, essoin>, and Joan his wife. Plea: debt of 3s.4d. He says that William and Joan owe and unjustly detain 3s.4d. for 4 measures (*pays*) of tallow (*sepe*), which William and Joan should have paid at Michaelmas last [29 Sept 1440]; they paid nothing but refused to pay and still refuse. Damages: 12d. He produces suit. William and Joan in their own persons come and say they owe him nothing. Inq.

**58** [INQ] ... <rests, default of jurors> Geoffrey Kneton and John Bryd, by John Moreton their attorney, complain of Thomas Farley of Nottingham. Plea: debt of 4s. They say that Thomas on Sat before Michaelmas 19 Henry VI [24 Sept 1440] bought a quarter of malt (*bras' ordei*) from them for 4s., to be paid at the feast of St Denis following [9 Oct 1440]; he paid nothing but refused to pay and still refuses. Damages: 12d. They produce suit. Thomas in his own person comes and says he owes them nothing. Inq.

**59** [INQ] ... William Mylnhagh of Kimberley, by Richard Dalbury his attorney, complains of Nicholas Brunnesley, parson of the church of Eastwood <essoin>. Plea: debt of 6s. William says that Nicholas owes and unjustly detains 6s. for herbage leased this year, which Nicholas should have paid to William at Michaelmas last [29 Sept 1440]; he paid nothing but refused to pay and still refuses. Damages: 12d. He produces suit. Nicholas in his own person comes and says he owes him nothing. Inq.

**60** [INQ] ... Ralph Hill of Higham (*Hegham*), by John Moreton his attorney, complains of William Webster of Ruddington <essoin>. Plea: debt [of 43s.4d.]. He says that he owes and unjustly detains 43s.4d. for ..., which William should have paid at the feast of St Martin ...; [he paid nothing but] refused to pay and still refuses. ... William in his own person comes and says he owes him nothing. [Inq.]

**62** M William Spenser in his own person complains of William Benyngton <licence>. Plea: trespass against the [king's] peace. William B[enyngton] for a licence in mercy.

**63** M William Benyngton <np> complains of William Spenser. Plea: trespass against the king's peace. William Benyngt[on] np. In mercy.

**64** M The same William Benyngton complains of the same William Spenser. Plea: trespass against the [king's] peace. The same William Benyng[ton] np. In mercy.<sup>5</sup>

**462** M John Harryson for a licence to agree with William Mascury in mercy. Plea: trespass against the [king's] peace. Plg: John Westhall, bailiff.

**463** M Roger Fox for a licence [to agree] with Robert Grene in mercy. Plea: trespass against the [king's] peace. Plgs: the bailiffs.

**464** M John Dorham complains of John Pylgrym. Plea: debt. John Pylgrym for a licence in mercy.

**465** PAID M John Ilkeston complains of William Colyer. Plea: debt. William for a licence in mercy.

**466** REATTACH CAPTION Samson Strelley, by Richard Dalbury his attorney, complains of Henry Derby of Nottingham, servant of William Colvyle. Plea: trespass against the king's peace. Attached by the body. Delivered (*liberatur*) by the mainpern of the said William. Henry charged. Did not come. Defaulted. Precept to reattach. William taken for the king's fine. Fine assessed at 6d.

**Further forinsec pleas held on Thur in the feast of St Matthew in the above year [21 Sept 1441].**

**467** INQ VOID PLG PROS JOHN COST, ADAM FOX Richard Chetewyn in his own person complains of William Alen, *corviser*. Plea: trespass against the king's peace. He says that William on Sat after the feast of the exaltation of the HC 20 Henry VI [16 Sept 1441] with force and arms (staff and dagger) made an assault on Richard, beat, affrayed and maltreated him. Damages: 40s. He produces suit. William in his own person comes and says he is not guilty. Inq.
