**3** INQ PLG PROS AS ABOVE Richard Wodehall, by Richard Campion his attorney, complains of Ralph Cost. Plea: detinue of a cow worth 10s. He says that Richard at Easter 24 Henry VI [28 Mar 1446] delivered the cow in the safe custody of Ralph; he restored nothing but unjustly detains. Damages: 10s. He produces suit. Ralph comes and says he does not detain the cow. Inq.

**4** INQ PLG PROS AS ABOVE Robert Baxster of Nottingham in his own person complains of Ralph Cost. Plea: debt of 15s. He says that he owes and unjustly detains 15s. for sheep bought from him, which Ralph should have paid at Michaelmas 21 Henry VI [29 Sept 1442]; he paid nothing but refused to pay and still refuses. Damages 3s.4d. He produces suit. Ralph in his own person comes and says he owes him nothing. Inq.

**5** INQ M PLG PROS JOHN EST, WILLIAM WEST <np> John Bate snr of Stoke Bardolph in his own person complains of Thomas Alrede of Wilford. Plea: trespass

against the king's peace. He says that Thomas on Mon after the feast of the invention of the HC 23 Henry VI [8 May 1445] with force and arms (staff) made an assault on John and mowed, took and led away two doles of his grass worth 3s.11d. Damages: 6s.8d. He produces suit. Thomas in his own person [comes] and says he is not guilty. Inq. Np.

**6** INQ M PLG PROS JOHN EST, ADAM FOX <np> The same John Bate in his own person complains of John Alrede of Wilford. Plea: trespass against the king's peace. He complains that John Alrede on Thur after the feast of invention of the HC 23 Henry VI [4 May 1445] with force and arms (staff) destroyed and wasted his hay with his horses worth 3s. Damages: 6s.8d. He produces suit. John Alrede in his own person comes and says he is not guilty. Inq. Np.

**7** PAID M Robert Smyth at Bridge End (*atbr*) complains of Robert Grene, *tailliour*. Plea: detinue. Robert Smyth np.

**8** M Reynald Idursaye complains of Thomas Knyght of Eastwood. Plea: trespass against [the king's] peace. Thomas for a licence in mercy. Plg: Richard Chestrefeld, Robert Nicholason.

**18** INQ PLG PROS AS ABOVE John Alrede of Wilford, by William Alrede his attorney, complains of John Bate snr of Stoke Bardolph. Plea: trespass against the king's peace. He says that John Bate on Sat before the feast of St Wilfrid 24 Henry VI until Mon following [9 x 11 Oct 1445] with force and arms (staff) unjustly and without right made him prisoner. Damages: 6s.8d. He produces suit. John Bate in his own person comes as above. [Inq.]

**19** INQ PLG PROS AS ABOVE Robert Elysoun, by John Moreton his attorney, complains of John Bate of Stoke Bardolph. Plea: trespass against the king's peace. He says that when Robert on Mon after Michaelmas 24 Henry VI [4 Oct 1445] arrested divers goods: a black horse worth 6s.8d. and other household utensils worth 5s. for rent of 4s., John on the said day with force and arms (staff) broke the arrest, took and carried off the goods. Damages: 3 nobles.<sup>1</sup> He produces suit. John Bate in his own person comes and says he is not guilty. Inq.

He says that he owes and unjustly detains 22d. for cloth bought from him, which Richard should have paid at Michaelmas last [29 Sept 1445]; he paid nothing. Damages: 6d. Richard in his own person comes and says he owes him nothing. Inq.

**21** INQ M <np> Thomas Marmeon, by Richard Dalbury his attorney, complains of William Hill of Plumtree, *tailliour*. Plea: debt. He says that William on Thur before the feast of St Martin 19 Henry VI [10 Nov 1440] borrowed 2s. from Thomas, and also on Wed before the feast of the translation of St Thomas 21 Henry VI [3 July 1443] borrowed 2s., to be paid at the feast of St Mary Magdalene following [22 July 1443]; he paid nothing but refused to pay and still refuses. Damages: 20d. He produces suit. Robert in his own person comes and says he is not guilty. Inq. Robert for a licence in mercy.

Damages: 12d. He produces suit. John in his own person comes and says he owes him nothing. Inq.
