**1** M Thomas Porter, rector of the church of Codnor, by William Glosse his attorney, complains of William Solers of Nottingham. Plea: debt of 6s.8d. William for a licence in mercy.

**2** PAID M Thomas Kerver of Nottingham complains of John Watson his servant. Plea: trespass and contempt. Thomas np. In mercy.

**3** PAID M The same Thomas complains of the same John. Plea: trespass and contempt. Thomas np. In mercy.

**4** PAID M John Salbury of Ancaster complains of Simon Eston of Lincoln, clerk. Plea: trespass. John np. In mercy.

**5** M William Clousse of Nuthall complains of Thomas Annesley of Newthorpe. Plea: trespass. Thomas for a licence in mercy. Plg: Richard Chesterfeld.

**9** PAID M William Barkar of Lowdham complains of Robert Thokkar of Crich. Plea: trespass against the [king's] peace. Robert for a licence in mercy.

**10** PAID M The same William complains of the same Robert. Plea: debt of 4s.4d. Robert acknowledges. In mercy. Levy.

**11** PAID M The same Robert complains of the same William. Plea: debt of 12d. William for a licence in mercy. Levy.

**12** M John Hurtsky of Barton on Humber complains of John Dalley of Nottingham. [Plea]: debt. John Dalley for a licence in mercy.

**13** M Thomas Hoychgee of Watnall complains of William Ryddynge of Riddings <3+>. Plea: debt. William for a licence in mercy.

**14** INQ Thomas Bachler of Nottingham, *sawer*, attached to reply to Robert Sclater of Nottingham. Plea: trespass against the king's peace. Plgs pros: John Est, William West. Robert, by Richard Chesterfeld his attorney, complains that Thomas on Wed after the feast of St Matthew 25 Henry VI [28 Sept 1446] with force and arms (staff and knife) made an assault on Robert, beat and wounded him. Damages: 40d. He produces suit. Thomas in his own person comes and defends the force and says he is not guilty. Inq. Precept to the serjeants at mace to summon a jury of 12 on Wed after the feast of St Denis following [12 Oct 1446]. Thomas in his own person comes. The jurors charged and tried. The jurors say that Thomas is not guilty. Adjudged that Robert should recover nothing v Thomas. Robert for his false claim in mercy.

**15** INQ Simon Eston lately of Lincoln, clerk, attached to reply to William Cook of Nottingham. Plea: trespass [against the king's peace]. Plgs pros: Adam Est, John West. William complains that Simon on Sat after Michaelmas 25 Henry VI [1 Oct 1446] together with others with force and arms (swords, bows and arrows) broke his house and close, made an assault on William, affrayed and maltreated him. Damages: 100s. He produces suit. Simon in his own person comes and defends the force and says he is not guilty. Inq. Precept to the serjeants at mace to summon a jury of 12 on Wed after the feast of St Denis following [12 Oct 1446]. The parties come in their own persons. The jurors chosen, sworn and tried (*et juratores ad hoc electi jur' et triati*). The jurors say that Simon is guilty and

assess damages at 40d. Adjudged that William should recover v Simon 40d. Fine assessed at 3s.4d.

**16** INQ John Wrygh[t] of Keyworth summoned to reply to Robert Jebbe of Kinoulton <np>. Plea: debt. Plgs pros: John Cost, John Fox. Robert in his own person says that John Wryght hired Robert on Tues after Whitsun 24<sup>3</sup> Henry VI [7 June 1446] to Michaelmas following [29 Sept 1446] to serve (*ad deserviend*) Robert Fancourt as a shepherd (*in officio pastoris*) for a salary of 3s.4d., to be paid at the feast of St Martin following [11 Nov 1446]; he rendered nothing but refused to render and still refuses. Damages: 12d. He produces suit. John Wryght comes, by Richard Chesterfeld his attorney, and defends (*denfendit*) the force and says he owes him nothing. Inq.

**17** LEVY INQ Robert Cotrel complains of John Pastlow. Plea: debt of 4d. Robert says that he owes and unjustly detains 4d., to be paid at the feast of St Peter advincula [? 1 Aug 1446];<sup>4</sup> [he paid] nothing. John comes, by Richard Chesterfeld his attorney, and says he owes him nothing. Inq. The jurors say he owes the debt. [Adjudged] that he should recover.

**18** LEVY Nicholas Bryge of Nottingham, *bocher*, summoned to reply to William Barkar and Joan Bar, executors of the will of Robert Barkar. Plea: debt of 20s. Nicholas, by Robert Watnow his attorney, comes and acknowledges. Adjudged that William and Joan should recover v Nicholas 20s. and 12d. damages.

**19** INQ M Robert Benet of Nottingham, *corvicer*, and Agnes his wife attached to reply to Thomas Doo of Nottingham <np> and Matilda (*Matild*) his wife. Plea: trespass against the king's peace. Plgs pros: John Est, William West. Thomas and Matilda, by Robert Watnow their attorney, complain that Agnes on Wed before Michaelmas 25 Henry VI [28 Sept 1446] made an assault on Matilda with force and arms (staff), beat and wounded her. Damages: 6s.8d. They produce suit. Robert Benet and Agnes his wife in their own persons come and defend the force and say she is not guilty. Inq. Precept to the serjeants at mace to summon a jury of 12 on Wed after the feast of St Denis following [12 Oct 1446]. Thomas and Matilda charged. Do not appear. Adjudged that Thomas and Matilda np. In mercy.

**20** INQ M The same Robert and Agnes his wife attached to reply to the said Thomas and Matilda his wife. Plea: trespass against the king's peace. Plgs pros: John Cost, Richard West. Thomas and Matilda, by Robert Watnow their attorney, complain that Agnes on Wed before Michaelmas 25 Henry VI [28 Sept 1446] with force and arms (staff) made an assault on Matilda and took and carried off a *crafter* worth 4d. and a chemise worth 12d. Damages: 6s.8d. They produce suit. Robert [and] Agnes in their own persons come and defend the force and say she is not guilty. Inq. Robert and Agnes for a licence [in] mercy.

**21** M Thomas Ivynet complains of Thomas Doo. Plea: debt of 11d. Thomas Ivynet, by Richard Chesterfeld his attorney, says that he owes 11d.: 8d. for a half dozen ale and 3d. outstanding on a pair of shoes. Thomas Doo in his own person comes, acknowledges 9d., offers 9d. and says he was always ready to pay 9d. Inq. As to 2d., he says he owes him nothing. Inq. Thomas Doo for a licence in mercy.

**22** M John Meremon lately of Wiverton (*Weyrton*) attached to reply to Robert Butler of Cropwell Butler. Plea: trespass against the king's peace. Plgs pros: William West, John Fox. Robert complains, by Richard Chesterfeld his attorney, that John on Mon after Michaelmas 25 Henry VI [3 Oct 1446] with force and arms (staff) broke his house and close and took and carried off Matilda (*Matild*), Robert's wife, and divers goods: a russet robe worth 6s.8d. and a red hood worth 3s.4d. Damages: 100s. He produces suit. John in his own person comes and defends the force [and] says he is not guilty. Inq. Robert np. Adjudged that he should recover nothing. In mercy.

**23** INQ John Lyverych complains of John Hugyn of Nottingham. Plea: debt of 2s. Plgs pros: John Cost, Richard Frost. [John] Lyverych in his own person says he owes and unjustly detains 2s. for making 2 saddles, which he should have paid at Whitsun 21 Henry VI [9 June 1443]; he paid nothing. Damages: 6d. He produces suit. John Hugyn in his own person comes [and] says he owes him nothing. Inq. As above.

**24** M John Lyverych attached to reply to John Hugyn <np>. Plea: trespass and contempt against the ordinance and statute of labourers. Plgs pros: Adam Est, William West. John Hugyn in his own person complains that John Lyverych [withdrew] from his service without reasonable cause and licence. John Hugyn

with John Lyverych on Mon after the feast of the annunciation of the BVM 21  
 Henry VI [1 Apr 1443] ...<sup>5</sup>

**25** M <licence> John Jolyvet summoned to reply to William Ingelbryght. Plea: debt. Plgs pros: John Cattiswruth, William Lyng. William, by John Catteswruth and William Lynge his attorneys, says that John Jolyvet on Sat after the feast of St Martin 22 Henry VI [16 Nov 1443] bought meats worth 26s.8d.: ox meat, sheep meat and calves' meat, to be paid at Michaelmas following [29 Sept 1444]; he paid nothing but refused to pay and still refuses. Damages: 3s.4d. He produces suit. John Jolyvet in his own person comes and defends the force and says he does not owe 26s.8d. nor any parcel. Law with 12 hands. John for a licence in mercy.

**Further forinsec pleas held on Thur before the feast of St Denis in the said year [6 Oct 1446].**

**26** [LAW] Simon Eston lately of Lincoln, chaplain, summoned to reply to Nicholas Bothby, vicar of Ancaster. Plea: debt of 16m. Plgs pros: Richard Chesterfeld, Robert Rote. Nicholas, by Richard Chesterfeld his attorney, says that Henry Drewry, chaplain, on 20 Dec 20 Henry VI [1446] borrowed from Nicholas, vicar of Ancaster, 21m 6s.8d., to be paid at Easter following [1 Apr 1442]. For greater security Simon became Henry Drewry's pledger to Nicholas for 16m on Sun before Michaelmas (*sancti Machaelis*) 25 Henry VI [25 Sept 1446] and agreed to pay Nicholas 16m if Henry should not pay (*colverit*) on Wed following [28 Sept 1446]; he did not pay [whereof] the action accrued to Nicholas to seek 16m from Simon; he paid nothing but refused to pay and still refuses. Damages: £10. He produces suit. Simon in his own person comes and defends the force and says he never became Henry's pledger. Law with 12 hands on Wed before the feast of St Simon and St Jude following [26 Oct 1446]. Plgs at law: John Kartar, William Forbar. Simon charged and appeared in his own person but his [compurgators] did not come. Adjudged that Nicholas should recover v Simon and damages in respite until the mayor ...<sup>6</sup>

**27** INQ Robert Alestre of Nottingham, *roper*, complains of William Madershey of the same, *roper*. Plea: trespass and contempt against the ordinance and statute of labourers. Plgs pros: Adam Est, Robert West. Robert in his own person says that William on Mon after Michaelmas 25 Henry VI [3 Oct 1446] was retained to serve him as a roper (*in offic' roperie*) until Sat following [8 Oct 1446]; William on Tues after the said feast [4 Oct 1446] without reasonable cause and licence withdrew. Damages: 2s. He produces suit. William [in his] own person comes and says he was not retained with Robert. Inq.

**Further forinsec pleas held on Wed before the feast of St Simon and St Jude in the said year [26 Oct 1446].**

**28** [INQ] <licence> William Barbour of Nottingham complains of William Wulthwayt, *plasterer*. Plea: trespass against the king's peace. Plgs pros: John Cost, John Est. William complains that William Wulthwayt on 10 May 24 Henry VI [1446] with force and arms (staff) made an assault on William Barbour, affrayed and maltreated him. Damages: 6s.8d. He produces suit. William Wulthwayt in his own person comes and defends the force [and] says he is not guilty. Inq.

**29** INQ <np> William Langton complains of John Pastlow of Nottingham, *payntor*. Plea: trespass against the king's peace. Plgs pros: John Rest, John ... William in his own person complains that John on Fri after Whitsun 24 Henry VI [10 June 1446] with force and arms (staff) broke his house and close and persuaded (*consi...avit*) Margery his servant from his service. Damages: 20s. He produces suit. John in his own person comes and defends the force [and] says he is not guilty. Inq.

**30** INQ Thomas Bachler complains of Robert Sclater of Nottingham <licence>. Plea: trespass against the king's peace. Plgs pros: Richard Chesterfeld, John West. Thomas in his own person complains that Robert on Tues after Michaelmas 22 Henry VI [1 Oct 1443] with force and arms (staff) made an assault on Thomas and made him prisoner without cause and right (*judicio*) for a day and a night. Damages: 6s.8d. He produces suit. Robert in his own person comes [and] says he is not guilty. Inq.

**43** [INQ] The same Robert complains of the same Roger. Plea: trespass against the king's peace. Plg pros: Benedict Paternoster. He says that Roger on Wed the feast of St Matthew 25 Henry VI [21 Sept 1446] with force and arms (bows and arrows) [made] an assault on Robert, affrayed and maltreated him. Damages: 6s.8d. He produces suit. Roger in his own person comes and defends the force [and] says he is not guilty. Inq. Mainpern of John Sclater.

**44** LICENCE M Thomas Jarves, by Robert Watnow [his] attorney, [complains] of John Etyngton. Plea: trespass and contempt against the ordinance and statute of labourers. Plgs pros: Adam Est, John West. He says that John was retained with Thomas from Christmas last [25 Dec 1445] to serve him in his work (*in labore suo*) for a year; John on Mon after the feast of the purification of the BVM last [7 Feb 1446] without reasonable cause and licence withdrew from his service. Damages: £4. He produces suit. John in his own person comes and defends the force and says that on Sun before the feast of the purification of the BVM last [30 Jan 1446] John made an assault on him with a dagger so that his life was despaired of and so he withdrew with reasonable cause. Thomas says he made no assault on him. Inq.

**45** M Richard Blowut, *tyler*, complains of Elizabeth Wheytley. Plea: trespass. Richard np. In mercy.

**46** M Thomas Wryght of Nottingham complains of John Raw. Plea: trespass against the [king's] peace. Thomas np. In mercy.

**47** M John Wylyn of Moorgreen complains of Nicholas Brynsley, rector of Eastwood. Plea: trespass against the [king's] peace. Nicholas for a licence in mercy.

**48** M John Fox of Lenton complains of the same Nicholas. [Plea]: trespass. Nicholas for a licence in mercy.

He says, by Richard Chesterfeld his attorney, that Henry on 20 Apr 23 Henry VI [1445] broke his house and close with force and arms (staff and knife) and took, carried off and abducted Joan, John's wife, 2 pots worth 3s.4d., 2 dishes worth 5s., 3 coverlets worth 10s. and 2 pairs of linen sheets worth 4s. Damages: £10. He produces suit. Henry in his own person comes and defends the force [and] says he is not guilty. Inq.

**51** INQ PAID M William Bower of Nottingham jnr in his own person complains of Henry Ravyn of Wilford <+>. Plea: debt of 2s.6d. for the hire of a cow. He says that Henry hired a cow from him on 10 May 23 Henry VI [1445], to render 2s.6d. at the feast of the invention of the HC last [3 May 1446]; he paid nothing. Damages: 6d. He produces suit. Henry in his own person comes [and] says he owes him nothing. Inq.

**52** INQ William Mason, *tailor*, in his own person complains of John Skeldynghope <essoin>. Plea: debt of 6s.8d. He says that he owes and unjustly detains 6s.8d. for herbage (*harbagio*) of a croft from Whitsun last [5 June 1446] to Michaelmas following [29 Sept 1446], which he should have paid at Michaelmas [29 Sept

1446]; he paid nothing. Damages: 6d. He produces suit. John in his own person comes [and] says he owes him nothing until Christmas [25 Dec 1446]. Inq.

**53** [INQ] Richard Blowut, *tyler*, in his own person complains of Hugh Makepese. Plea: trespass against the king's peace. Plg pros: John West. He says that Hugh on Thur after Michaelmas 25 Henry VI [6 Oct 1446] broke his house and close with force and arms (staff and knife) and took and carried off Joan Peyte his servant and 3s.4d. Damages: 20s. He produces suit. Hugh in his own person comes and defends the force and says he is not guilty. Inq. Plg: William Coke.

**54** [M] John Marchal of Burton on Trent, by William Lyng his attorney, complains of Richard Odham of Nottingham <+>. Plea: debt.

Damages: 40s. They produce suit. Godith in her own person comes and defends the force and says she was not retained with John and Alice nor withdrew from their service. Inq.

**56** LEVY M Robert Howet of Kegworth (*Keggew*), chaplain, by Robert Watnow his attorney, complains of John Jolyvet of Nottingham, *bocher* <+>. Plea: debt of 3s. John in his own person comes and acknowledges. Damages: 2d. Adjudged that Robert should recover 3s. and 2d. damages. J[ohn] in mercy.

**57** M John Buron, Kt, complains of Thomas Williamson of Kirkby Kendal (*Kyrkbykendal*). Plea: trespass against the king's peace. John np. In mercy.

**58** PAID M Thomas Jebbe of Colwick complains of Raphael Sclater of Kirkby Kendal. Plea: debt. Raphael for a licence in mercy.

feast of the BVM<sup>7</sup> 22 Henry VI [1 sEPT 1443 x 31 Aug 1444] with force and arms (staff and knife) broke John's house and close and took and carried off 3 scythes worth 7s., 100 horse shoes (*horsshou*) worth 6s., 6 *shelbreydolotys* worth 12d., 300 horse shoe nails (*horssho neylys*) worth 9d. and 6 plough slips (*plowslypis*) worth 12d. He says that he owes and unjustly detains 25s. for a sheep skin (*pro pell' ovinis*) bought from John on Sat after the feast of St Dunstan 20 Henry VI [26 May 1442], to be paid at the feast of St Martin following [11 Nov 1442]; he paid nothing but refused to pay and still refuses. Damages: 3s.4d. He produces suit. John in his own person comes [and] says he owes him nothing. Inq.
