Cecilia in her own person comes in court, and having been sworn and examined by the mayor and bailiffs, acknowledges the charter to have been made by her own wish without pressure from her husband. Robert has ratified the charter. She has rendered all her right and claim after the death of John, her husband, to Robert. Letters of attorney by John Godard and Cecilia his wife, daughter and heir of William Torlaton lately of Nottingham, to Hugh Monnk and Thomas Beauchampe to deliver seisin to Robert Torlaton of Nottingham, their kinsman, of all lands, tenements and meadows, above ground and underground, in Nottingham, according to the form of their charter. Robert in his own person says that Thomas and Margery on Sat before the feast of the Circumcision 16 Henry VI [31 Dec 1437] with force and arms (staff and dagger) made an assault on Richard his

servant, beat, affrayed and maltreated him by which he lost his service for a long time. Damages: 20s. He produces suit. Thomas in his own person and Margery, by Thomas her attorney, come and defend the force and say they are not guilty. Precept to Robert Watnow, one of the serjeants at mace, to empanel a jury of 12 for Wed before the feast of St Gregory next [6 Mar 1448], and to produce Robert, Thomas and Margery. Jurors: William Couper, Richard Cutler, Richard Goldeon, John Torlaton, Richard Shermon, Robert Leck, John Lenton, Richard Brace, Richard Fleccher, Henry Sothorn, William Burton and William Mason. They say that Thomas and Margery are guilty and assess damages at 3s.4d. Because the mayor was not present, day given to the parties to be before the mayor and bailiffs on Wed after Easter following [27 Mar 1448] to hear judgement and to make the king's fine.

145 LEVY M William Clerke of Nottingham, *skynner*, summoned to reply to Nicholas Plumptre. Plea: debt of 13s.4d. Plgs pros: John Hert, William Smert. Nicholas in his own person says that William on Sat after Michaelmas 21 Henry VI [6 Oct 1442] bought from him a half hundredweight of budge (*underth' de budgee*) worth 13s.4d., to be paid at the feast of St Martin following [11 Nov 1442]; he paid nothing but refused to pay and still refuses. Damages: 3s.4d. He produces suit. William, by Richard Chesterfeld his attorney, comes and acknowledges the debt. Adjudged that Nicholas should recover v William 13s.4d. and 4d. damages. In mercy.

Grant by John Lyversegge and Alice his wife to Thomas Thurland of Nottingham, merchant (*m'catori*), of four cottages lying together in the Daily Market between Thomas' land on the eastern part and the guild hall of Nottingham (*gyldam aulam ville Notynghamie*) on the western part; they abutt on Thomas' land towards the south and on the highway towards the north, which cottages they lately had of the gift and feoffment of John Wolaton of Nottingham. Warranty. Sealing. Witd: Thomas Heth and Thomas Mylys, bailiffs, Richard Samon, John Plumptre, Thomas Alestre. Nottingham, 11 Oct 26 Henry VI [1447]. Alice, wife of John Lyversygge, in her own person comes in court and was sworn and examined on the making of the charter. She acknowledges the charter to have been made of her own free

will without pressure or distraint of John her husband, releases all her dower and other rights after the death of her husband, and likewise seeks enrolment.
