1 PAID M Thomas Brygeford complains of John Bethby. Plea: debt. Licence.

2 PAID M Richard Turton, *spycer*, complains of John Hill. Plea: debt. Np.

3 [M] John Large <np> complains of Thomas Padyan. Plea: debt of 4s.10d. Summoned. Does not come.

4 M John Mapurley <licence> complains of Thomas Iremonger. Plea: debt of 5s.2½d. Summoned. Does not come.

5 M John Dorham complains of Katherine widow of William Clerk, *skynner*. Plea: trespass.

6 M The same John complains of the same Katherine. Plea: detinue of 6 towels (*manutargia de towyll*) worth 10s. [and] 6 tablecloths (*map*) worth 10s. Licence.

7 PAID M Thomas Sergeant, *pewtrer*, <np>, complains of John Bothby, *pewtrer*. Plea: debt of 10s.

8 [M] To this court comes William Brygge and mainperned to have the body of William Armorer at the next court.

9 M John Warnar <+> summoned to reply to John Marchall. Plea: debt. Charged once. Does not come.

10 M Robert Alen <+> summoned to reply to Robert Capulwod, *bower*. Plea: debt. Charged twice. Does not come.

11 M William Fyssher, *plasterer* <+> and John Blakburn <+> summoned to reply to John Assh, *sadler*. Plea: debt. Charged 4 times. Do not come.

12 M John Marreys <+> summoned to reply to John Hampton, *bakar*. Plea: debt. Charged 4 times. Does not come.

13 M The same John Marrys <+> summoned to reply to John Spenser. Plea: debt. Charged 4 times. Does not come.

14 M Robert Tyler, *smyth* <+>, summoned to reply to Edmund Hydys. Plea: debt. Charged 4 times. Does not come.

15 M The same Robert <+> summoned to reply to Ralph Hall. Plea: debt. Charged 5 times. Does not come.

16 M <np> John Brynnesley summoned to reply to Thomas Bander. Plea: debt. Charged 5 times. Does not come.

17 M <defaulted> John Gell, *corvicer*, summoned to reply to John Barton. Plea: debt. Charged 6 times. Does not come.

18 M <did not appear> Thomas Padyan <+> summoned to reply to Richard Dalby. Plea: debt. Charged 6 times. Does not come.

19 M Robert Cokkar <+> summoned to reply to Richard Dalby. Plea: debt. Charged 7 times. Does not come.

20 M William More <+>, Thomas Kendall <+> and Thomas Paduby [?] summoned to reply to John Dorham. Plea: debt. Charged 3 times. Do not come.

21 M Robert Bower, *payntor* <+>, summoned to reply to William Perkyn. Plea: debt. Charged 9 times. Does not come.

22 M Robert Capulwod, *bower* <+>, summoned to reply to Richard Dalby and Thomas Mylys. Plea: debt. Charged 13 times. Does not come.

23 [ENROLMENT] To this court came (*venerunt*) Richard Byngham, one of the king's justices of the bench, and Robert Ferthyng of Basford offering a charter which they had made to Richard Turnour of Nottingham. Richard Byngham and Robert assert the charter to have been lawfully made and seek the charter to be read, publicly pronounced and enrolled as the custom is. Release and quitclaim by Richard Byngham, one of the justices of the king's bench, and Robert Ferthyng of Basford to [Richard] Turnour of Nottingham ...¹
