

Downloading your document - after completing registration

1. Now you have completed your registration and obtained a username and password **you must now go back to your original BL email** and follow the STEP 2 path to download your document. It can **take up to ten minutes** for records to be updated with a new registration so please **allow this time** before downloading your document or retry if your initial download attempt fails.
2. Enter your **username** and click on **Download** you document.

Your document has been encrypted with DRM Lite encryption technology. You should open your document with Adobe Reader. If your browser has a built-in PDF viewer, such as the one found in Google Chrome, then you will need to disable it in order to download and view your document.

- **If you are registered for the On Demand service.** After we request an article on your behalf via BL you will receive the email below since the system recognises your registered email address. You will be prompted to click on the download link to access your document:



- The article is not automatically saved and you must save it to a device when prompted by your browser or click 'File>Save As' in Adobe Reader. Once the document is saved, you will have access to it for three years from the date of supply, after which you will be locked out of the document permanently. If files are not saved, access from the download link will expire after 30 days and the item will need to be re-ordered.
- **If you have forgotten your username or password**, you can request a reminder to be sent to your registered email address from the login link on the [On Demand home page](#). If your password changes, you can continue to access saved documents using your latest password. However, you may need to clear the remembered account information in Adobe Reader. You can do this by going to 'Edit'>'Preferences'>'Security' and clicking and confirming the 'Clear remembered account information' option.
