# **Collection and storage**

You can browse the PRIMIS website without telling us who you are or revealing any personal information about yourself. However, once you give us your personal information, you are no longer anonymous to us.

If you choose to provide us with personal information, you expressly consent to us transferring that information to and storing it on, servers currently located within the European Economic Area (EEA), in a safe, confidential and secure environment, and using such personal information in association with the services we provide you. We have entered into European Commission approved standard contractual clauses with our data processors to help safeguard your data protection rights. A copy of the clauses are available on request.

We may retain the information you provide us with or we collect about you for the purpose of administering our services even after the expiry or termination of services unless you tell us otherwise.

Data is retained by PRIMIS for the corresponding period set out in our Retention and Destruction Schedule

# We collect and store the following personal information about you:

- email address, physical address, telephone number and other contact information (depending on the service used) for the purposes of:
  - o general contact
  - o information regarding PRIMIS products/services relevant to your membership or in accordance with your stated communication preferences
  - o any purchase(s) you make

## Marketing by third parties

We do not give your data to anyone outside of PRIMIS (with the exception of the University of Nottingham (UoN) when you purchase a PRIMIS product/service using the UoN Online Store). We do not sell or rent your personal information to anyone outside of your agreements with PRIMIS.

## **Use by PRIMIS**

Our primary purpose in collecting personal information is to provide you with a safe, smooth, efficient and customised environment and service.

The lawful basis for PRIMIS to process your personal data is that it is necessary for our legitimate interest in management of the contractual relationship and dealing with your enquires relating to the Services, as referred to in the General Data Protection Regulation (GDPR) ((EU) 2016/679), article 6 (b) – 'processing is necessary for the purposes of the legitimate interests pursued by the controller or by a third party, except where such interests are overridden by the interests or fundamental rights and freedoms of the data subject which require protection of personal data, in particular where the data subject is a child'.
