Panel Members Join Dermatology Specialty Group

CEBD Patient Panel members Jason Simons and Colette O' Sullivan have joined the Dermatology Specialty Group (DSG) to provide PPI input for this group. The DSG is chaired by Hywel Williams and the aim of the group is to help with the successful delivery of dermatology studies on the National Institute for Health Research portfolio, including CEBD studies such as STOP GAP. Volunteers Needed to Speak at SPRUSD Annual Meeting

The eagle eyed amongst you will have noticed that the Programme for the SPRUSD meeting on 8th November includes a session on 'Feedback from members of the patient panel – reflections on how the CEBD patient panel is progressing'. This means we need 2-3 volunteers who have been actively involved in CEBD research over the past 2 years to step forward and volunteer to speak informally for 5 minutes at the meeting about their experiences. Opportunity Within the NIHR Research for Patient Benefit Programme

The National Institute for Health Research Central Commissioning Facility (NIHR CCF) is looking for patient and public representatives (lay members) for the Research for Patient Benefit (RfPB) programme to take a part in the work of the ten regional advisory committees. The committees meet three times a year with individuals from clinical, academic and methodological backgrounds to discuss and decide which applications to the programme should be recommended for funding. Lay members take a full committee role and have the key task of providing the patient and public perspective in the research assessment processes. There are up to three lay members on each committee at present.

Committee experience and some healthcare background are useful. For example, you may be a service user or a carer, been a member of an ethics committee, or have worked with volunteer groups in a health related role. You must also reside in England. Eczema Research Update

We received over 1,000 questions related to uncertainties about research for eczema treatments and the research team are now categorising these to make them easier to manage. A ranking survey will follow in October and a top ten list will be produced at a workshop in January. Many thanks to all of you who contributed questions and to those panel members involved on the Steering Committee for this project.

The National Institute for Health Research (NIHR) are commissioning a research project on the use of silk clothing as a treatment for eczema . Those who attended the very first patient panel training event may remember that this is something CEBD have been interested in for a while and Kim Thomas is working on an outline grant application which will be submitted in September. If this is successful we'll then go ahead with a full application early next year.
